In the 1st and 2nd paragraphs, replace twice "skid and slip resistance" with "slip/skid resistance".

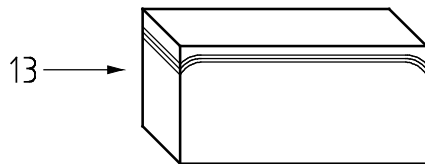
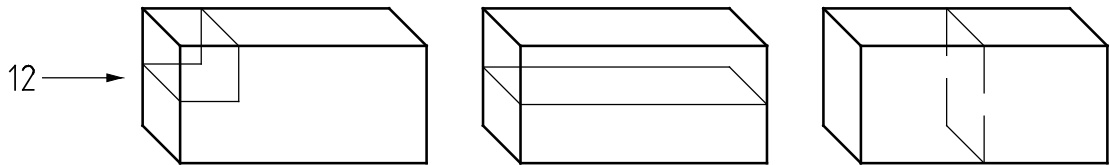
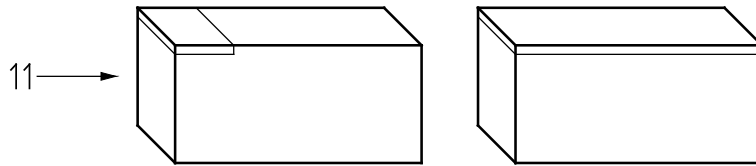
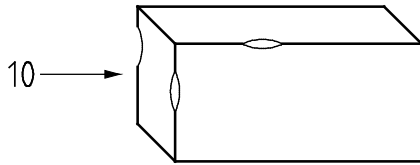
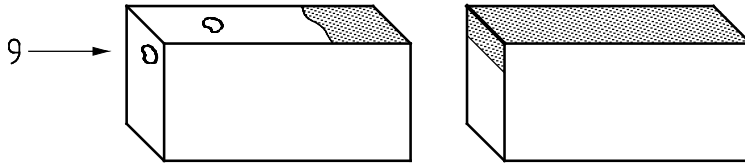
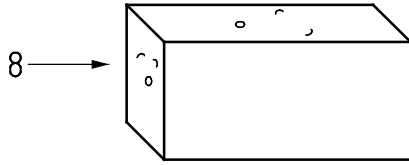
5 Modification to C.6, Evaluation of results — Assessment of damage
